

ADMISSION RULES – TRADE FAIRS

FIRA DE BARCELONA

These Admission Rules are mandatory for all professional visitors and/or members of the public accessing the premises of FIRA DE BARCELONA.

In order to access the venue, it is mandatory to present a valid ticket or an authorized pass. Access to and presence within the venue are subject to possession of such ticket or pass, which must be shown upon request to customer service staff and/or security personnel.

FIRA DE BARCELONA reserves the right of admission and makes official complaint forms available to the public upon request. The exercise of the right of admission shall in no case result in the denial of access to the ticket holder on grounds of race, sex, religion, opinion, disability, sexual orientation, or gender identity.

1. General Provisions

1.1. The following activities are strictly prohibited within the exhibition premises:

- Causing disturbances or engaging in actions that disrupt public order and/or damage the facilities.
- Entering with animals (except guide dogs), bicycles, skateboards, or similar items, except at events where this is expressly permitted.
- Smoking or using any type of vaping device inside the premises.
- Accessing the venue with flags, banners, or leaflets of an ideological or political nature, as well as any other items containing racist or xenophobic symbols or that incite violence or undermine human dignity. Accordingly, FIRA DE BARCELONA staff may remove such materials at any time, either prior to entry or within the venue, and they will be returned upon exit.
- Consumption of narcotic or illegal substances.

- Accessing the venue with weapons of any kind, sharp or blunt objects.
- Carrying out demonstrations, protests, or similar actions within the premises.

1.2. Visitors must respect emergency exits and fire safety areas, as well as comply with the instructions issued by **FIRA DE BARCELONA** staff to ensure safety within the venue.

1.3. Within the premises, visitors must behave in a manner that does not cause harm to themselves or others, nor cause inconvenience to other visitors or exhibitors. Visitors must at all times comply with the instructions of regional or state security forces, private security personnel, fire services, medical staff, the public address system, or any other duly authorized and identified personnel appointed by **FIRA DE BARCELONA**.

1.4. Attendance at events organized by **FIRA DE BARCELONA** implies authorization for the free assignment of image rights, for use through currently known technical means and any that may be developed in the future, for the maximum period permitted under intellectual property legislation and without any geographical limitation. Such images shall consist of general views of the event and shall be used exclusively for informational and promotional purposes.

This material may be reproduced, published, and/or disseminated on the event's website, social media platforms, and other online and communication channels of **FIRA DE BARCELONA**, solely for the purpose of promoting or publicizing its activities.

Interested parties may object to the processing of their image by sending an email to protecciodades@firabarcelona.com , in accordance with Organic Law 3/2018 of 5 December on the protection of personal data and the guarantee of digital rights.

1.5. Any person who fails to comply with these rules may be expelled from the venue without any compensation or refund of the ticket price. The same applies to any person expelled for being under the influence of alcohol and/or narcotic substances, behaving violently, disrupting public order, or where there is a reasonable risk that such behavior may occur.

1.6. Any visitor, in exercise of the linguistic rights provided for in Law 1/1998 of 7 January on language policy, has the right to express themselves and to be attended to in either of the two official languages of Catalonia.
