

# TERMS AND CONDITIONS HOSTED BUYER PROGRAM

Piscina & Wellness Barcelona 2023

*By participating in Piscina & Wellness Barcelona 2023's Hosted Buyer Program, you automatically accept the following terms and conditions:*

1. Hosted Buyers are designated according to the Organization's eligibility criteria: professional profile, company economical details (such as purchasing and importing volume), products of interest, geographical area, limit of places and budgetary restrictions. The Organization's decision is final.
2. The Hosted Buyer, once it is admitted in the Program, will have a limited period of time to confirm the participation and all procedures related (trip, hotel, etc). This period will be communicated as soon as the Organization confirmed the participation. In case the Hosted Buyer exceeds this period, the Organization will be able to dismiss the application or the Hosted Buyer would pay the remainder relatives to the flight tickets or hotel.

3. Hosted Buyers accepted into the program will enjoy the following benefits:

- A personalised agenda of meetings with key players and partners.
- Exclusive Access to the Network Area/VIP Lounge, tailored business meetings with exhibitors.
- Free Access to the VIP Lounge/Speakers' Room.
- Exclusive networking events for hosted buyer.
- Gala Dinner and Piscina & Wellness Awards Ceremony special invitation. (subject to availability).

## **SERVICES**

- Full or partial coverage of travel and/or accommodation expenses.
- Free Hosted Buyer ticket with preferential access for all the days the show is held.
- Priority attention in registration for activities and onsite accreditation.
- Access to Networking Area/VIP Lounge: rest area, business centre, networking and coffee area.
- Welcome Pack with meeting agenda planning and city guide.
- Personalised service during your visit, located in the Networking Area (VIP lounge).
- Wardrobe.
- Parking.

4. Participants will be responsible for any other expenses that the organisers do not agree to cover when acceptance into the program is confirmed.

**5.** The Hosted Buyer will be committed to:

- Pre registration online using the invitation code provided by the organization, and collect your welcome pack at the Organization office upon arrival at the trade show venue.
- Take part in at least 4 meetings with exhibitors of interest. The agenda will be managed with the assistance of the organization.
- Attend the networking activities suggested by the organization.

**6.** Participants who cancel once their ticket has been issued and/or their hotel reservation made must take responsibility for full payment of any fees which may be incurred as a result of the cancellation.

**7.** If a participant does not attend the show or fails to fulfil their obligations as a hosted buyer (item 5), they must reimburse the organisers for travel and/or accommodation expenses, except for force majeure.

**8.** When organising your travel/accommodation, the official envet travel agency, will request your credit card details and authorisation to charge your card for additional expenses incurred during your participation and not covered by the organisers (as indicated under item 3), as well as penalties for cancellation, non-attendance or failure to fulfil obligations on the part of the hosted buyer (see items 5, 6 and 7).

**9.** Flights will only be reserved from major airports. Departure and arrival airports must be the same.

**10.** By participating in the Hosted Buyers Programme, you consent to your company's general contact details (name, country, products and website), as well as your name and position, appearing on the Piscina & Wellness Barcelona website and/or printed materials at the fair as a participating company/professional.

**11.** Participation in the trade show as a hosted buyer is non-transferable. Should you be forced to cancel your participation in the trade show, another person from the same organisation may take your place. The organisers will make the final decision with regard to the person designated as a replacement.

**12.** Any hosted buyer who require a visa to travel to Spain must contact the organisers to request an invitation letter. Hosted buyer who are unable to travel because they do not have a valid visa will be subject to the penalties for cancellation and non-attendance (see items 6 and 7).

**13.** Any hosted buyers without a valid passport to travel to Spain will be subject to the penalties for cancellation and non-attendance (see items 6 and 7).

**14.** The Organisers will not cover any expenses arising from COVID tests required for travel to certain destinations. Hosted Buyers will have to bear the costs of these travel requirements. Hosted Buyers who are unable to travel for lack of these tests when required, will be subject to the payment of penalties for cancellation or non-attendance (see points 6 and 7).

**15.** The organisers reserve the right to reduce or extend the duration of the Show, as well as to postpone it, whenever special circumstances make it advisable or force majeure so requires. Such circumstances shall not be sufficient grounds for the Hosted Buyer to cancel its participation or to claim any compensation for damages.
